One environmental issue that has not received adequate attention is the proper disposal of hazardous chemicals. People routinely place products containing hazardous chemicals – insect sprays, paints, cleaning products, pharmaceuticals, batteries, etc. – into household trash. The chemicals from these products will eventually leach into our groundwater. While most municipalities offer a "Hazardous Waste" day once or twice a year, we must make more of an effort to educate the public about the importance of responsible disposal. And we must create more opportunities for responsible disposal, preferably with point-of-use collections.
